Domestic Assault Arrests

On Sunday, August 26th, **Officers Sean Smallen and Sarah Tollefson** responded to a reported domestic assault. The caller reported she had received a text message from the victim stating she had been assaulted and needed to go to the hospital. In meeting with the victim, officers could see redness and swelling under one eye. The victim reported she had been arguing with her boyfriend when he punched her

and grabbed her around the neck, making it difficult to breathe. Officers entered the residence and found the suspect, Dale Patrick, 49, sleeping. When awoken, he yelled "I am the devil", laughed and then lunged at the officers. He was taken into custody and jailed. Patrick was charged with Domestic Assault by Strangulation and Domestic Assault. His bail was set at \$20,000 with conditions.

Scams and Frauds and Phishing, Oh My

Along with many other cities, we've seen an uptick in scam calls. Your best bet is to simply hang up on these callers.

Scams range from persons claiming to be from the IRS, banking institutions, law enforcement to sweepstakes and computer support.

Law enforcement, government offices or financial institutions will never call and ask for your account information or threaten arrest.

Lottery or sweepstakes will never ask you to pay fees prior to getting any winnings.

Computer support technicians will never "cold-call" to offer their assistance. They are seeking to gain access to your computer or install malware. You should never disclose personal, financial, or computer access information to persons who call you unsolicited. If ever in doubt, call us to help you verify calls.

This week, we’re looking for Rebecca Ziemer, 41. She is the subject of a probation violation warrant related to convictions for 3rd degree Controlled Substances (Sales) and Fleeing a Peace Officer. Ziemer is 5’1” tall, weighs 141 pounds, has brown hair and brown eyes.

We are also looking for Oscar Lopez, 25, also known as Oscar Lopez-Campos. He is the subject of three warrants for failing to appear for charges of Violation of a Domestic Abuse No Contact Order (DANCO). He is also wanted in Scott County for 5th degree Assault. Lopez is 5’5” tall, weighs 137 pounds, has black hair and brown eyes.

Last on our list is Hal Edelman, 47. He is also the subject of a probation violation warrant for 5th degree Controlled Substances. Edelman is 5’10” tall, weighs 212 pounds, has gray hair and brown eyes.


